<u>Rules and Regulations</u>

- 1. Contestants must be daughters of an Ocean City property owner or year round resident meeting criteria on application check-list.
- 2. Contestants must be 12 years of age by August 1st, 2024 and must not have reached their 16th birthday prior to August 17, 2024.
- 3. The winner agrees to hold only the title of Junior Miss Ocean City throughout her reign. If the contestant holds another crown and wins Junior Miss Ocean City she must relinquish the other title to fulfill her commitment as Junior Miss Ocean City.
- 4. The winner agrees (without charge) to make appearances for the City's various events throughout the year of 2024-2025 until the next Junior Miss Ocean City Pageant. Ex: Baby Parade, Halloween Parade, Easter Fashion Show & summer special events, etc. Parents are responsible for their child and for transportation to and from the events.
- 5. Junior Miss will receive half of her winnings at the start of her reign and the other half upon the successful completion of her year of service.
- 6. Contestants must have available to wear: a semi-formal/formal dress, an outfit for their talent presentation, an outfit for the offstage interview. T-shirt and shorts will be provided for the opening number and will also be worn for the Baby Parade. You must provide white sneakers.
- 7. Judges decisions will be final .
- 8. The talent competition will be judged on talent potential only. Use of fire and knives are prohibited. Talent should be a minimum of 60 seconds and a maximum of 2 minutes. Judges will deduct points if longer than 2 minutes. Please email your talent music to events@ocnj.us by August 12, 2024! For vocalists the track must be instrumental ONLY. For pianists, violinists or any other instrumental talent NO background music is permitted. Props for talent cannot be larger than a folding chair and must be a usable prop. If a prop is going to be used you must get approval from the Pageant Director prior to the last week of rehearsal.
- 9. If any contestant, parent, or any member of contestant's party does not conduct himself or herself in an appropriate manner it may result in immediate disqualification. Good sportsmanship is a must.
- 10. The contestant must understand and sign the social media guidelines.
- 11. The contestant must be available for orientation on July 11, 2024 at the Ocean City Senior Center from 6:00-7:00 pm
- 12. The contestant must be available for all of the rehearsals outlines in the schedule and all day on Saturday, August 17, 2024. Exact report time will be in the morning and is TBD. The pageant will begin at 7:00pm.

<u>Important Info</u>

Pageant

- The pageant will consist of Interview, Talent, Onstage Question and Evening Gown Competition. There will also be opening and closing production numbers.
- Interviews will be conducted by pageant judges in private and will be 8 minutes long. Wear an appropriate business casual outfit.
- A special award will be given to the person who sells the most ads/sponsors for the pageant program book.
- All award winners will need to turn in a W-9 tax form and will need to complete an award invoice immediately following the crowning of Miss Ocean City. If you do not turn in a W-9 form and do not complete the voucher after the crowning, you will not receive your award money. Everything needs to be processed by September 1.
- The winner agrees to hold only the title of Miss Ocean City throughout her reign. If the contestant holds another crown and wins Miss Ocean City, she must relinquish the other title to fulfill her commitment as Miss Ocean City.

Pageant Orientation

- July 11 at 6:00 PM at the Ocean City Senior Center (18th and Simpson Ave)
- Arrive ready for individual headshot photos. These will be used in the Pageant Program Book and in pageant publicity.
- Orientation is open to contestants and one parent or guardian and should be about an hour.
- Ticket order form and facts sheet are due at Orientation

Rehearsals

- All rehearsals are mandatory.
- Monday 8/12, Tuesday 8/13, Wednesday 8/14, rehearsals will be held in the Cafeteria at OCHS.
- Tuesday 8/13 we will hold mock interviews to prepare you for interview.
- Be prepared to do your talent on Wednesday 8/14.
- Thursday 8/15 rehearsal will be at the Music Pier starting at 12:30 PM. Bring all shoes/costumes/gowns needed for all phases of competition including opening number. This will be our only time on stage to practice other than pageant day.
- All rehearsals are closed, meaning no parents, coaches, friends etc.
- Pageant Day is Saturday 8/17. Report time is TBD.

<u>Social Media Guidelines</u>

Expectations

- Avoid posting negative comments and pictures.
- Remember, posts never go away. Content lives on the internet forever.
- Be sure to set your privacy settings to the appropriate levels.
